Albany Law School—Kate Stoneman Day

Dale Engle Skivington (Class of 1976) received one of three 2010 Kate Stoneman awards at a program held at Albany Law School on Thursday, March 25th. The award is named in honor of Kate Stoneman, the first woman admitted to practice law in the state of New York in 1886 and Albany Law's first female graduate, Class of 1898. The award honors individuals who reflect the spirit of Kate Stoneman by actively seeking change and expanding opportunities for women. She was celebrated for her innovative work in the field of corporate privacy law and her community service. Dale noted "the award was really a great honor. I have been very fortunate in having wonderful women as mentors so it was especially meaningful. Congratulations on your achievement Dale!

Helping Children Realize Their Potential

Jean Quattrocchi Finnegan (Class of 1978) encouraged her middle school students to raise \$6,000 for a well to be built in Chigombe, Malawi. After viewing the film "Water First" by Amy Hart, she became aware of the work done by Charles Banda through his freshwater project which hopes to slow the spread of cholera, typhoid and malaria in his homeland in Africa. Jean's students raised the money through collection jars, bake sales, drawings, a garage sale, movie nights and a school-wide festival. They were able to purchase a pump and two latrines in the village of Chigombe, supplying water for the 414 students at the Kesinala village school. They also answered a call from Charles Banda and Jean's students arranged to have 1,000 books wheeled in on a cart at an assembly (which Jean had let her student's plan) with Mr. Banda in attendance. They dramatically unveiled the cartons of books and presented them to Banda. The school's principal, Mary Summermatter, opened the festivities by saying "it was to celebrate the power of what people can do when they come together to make something happen...for people we don't know that live almost a half-world away." Banda credited Jean by noting that after she saw the film that depicted his work. "It moved her spirit. She shared that with her students."

Jean told The Altamont Enterprise, in an article featured in their November 19, 2009 edition, "that she has long had an interest in Africa, and went to Kenya with a group of teachers in 2001, where she visited two schools and helped make bricks for a new room in a school." She hopes to do more work in Africa after she retires

Jean said to her students when they had raised the money, "Have you ever saved a life before? Well, now you have." She also told them that "no one is ever too small or too young to make a difference." Bravo Jeannie!!

Rochester Philharmonic Orchestra award

Jane has supervised numerous student teachers from Nazareth College and SUNY Fredonia, and received the 2009 Nazareth College Music Educator's Service Award. A Crane graduate, Jane also plays violin in the Penfield Symphony Orchestra, the Greater Rochester Women's Philharmonic Orchestra, and the Con Brio Strings Chamber Orchestra. Our recipient of this year's scholarship was a shy individual who credits pledging AGO as a starting point of her leadership abilities. Her first role in leadership in AGO came as the music mistress for AGO. She is currently a Justice on the Greek Board. Her greatest responsibility is being President of Alpha Kappa Phi which she greatly enjoys. Over the summer, she developed the Agonian Financial Contract to ensure that all payments of dues and fines are made to the House. She is also involved in

a Leadership Tutorial class that has improved her leadership abilities. She had to set three goals for the organization and she feels the success of her financial contract and the overall increase in the house GPA has been successful. She is currently updating the president's book and retyping all the pages. It is quite a project but it will be an improvement for the next president of Ago.

She stated that AGO has given so much to her that now it is her chance to return to AGO all that AGO has given to her. Her sponsor for this scholarship stated: "I have had the opportunity to work with Sarah for the past two semesters in her roles as a Justice on the Greek Judicial Board and, new this year, as president of her house. It would be easy, upon first meeting Sarah, to judge her in terms of a stereotype, but as soon as she engages you in conversation, you realize how harsh and inaccurate it would be to do so. Sarah is, by far, one of the best examples of what a true sorority woman should be. It is my sincere belief that one of the main reasons that Sarah is able to do this is because she is perpetually living her Agonian values. She strives for excellence and leads her house to do the same."

Under Sarah's leadership, Ago has been very active on campus and in the local communities. One of the things that they are doing is ncorporating and aiding other Greek houses in their activities. Thus far this semester, they have aided the College with Welcome Weekend and First Saturday activities, they have once again worked on the Cecile Garden Project (a service event that they recruited members of Phi Kap to help with), and they have supported Alpha's "Mud Tug" by having a team (a tug-of-war event whose proceeds went to support Children's Miracle Network). In an era where the All Greek Council executive board, are asking houses to come together as a more cohesive unit, Ago and Sarah are leading the way. 

Agonian Alumnae Association Scholarship—A Look Back

The Agonian Alumnae Association has been presenting scholarships to our undergraduate sisters at Potsdam and Clarkson for over 30 years. In May of 1978, we recognized Laurena Ramsdell, a longstanding member of our Board of Directors, by creating our first scholarship and naming it in her honor. The scholarship was originally in the amount of \$100 and was awarded to an Agonian who made "outstanding contributions to her Sorority while showing academic excellence." When our advisor of many years, Eunice "Brownie" Badger passed away, we chose to create a new scholarship in her memory. By 1991, we awarded this scholarship to recognize an Agonian who "exemplifies service to our sorority as well as to the Potsdam community." Over the years, the generosity and the commitment of our Alumnae has enabled us to increase the scholarships to \$1000. In 2004, we voted to add a third scholarship to recognize the leadership of the founder of our Alumnae Association, Suzanne Wadja, Class of 1974 and recipient of her MBA at Clarkson in 1976. This scholarship recognizes a sister who "exemplifies the Agonian sisterhood while demonstrating excellence in leadership." In 2005 and 2006, we presented all three \$1000 scholarships to deserving sisters. While we wish we could continue awarding all three, we instead offer one \$1000 scholarship each year.

As our Scholarship Committee reads through the applications and letters of recommendation from faculty, we marvel each year at the GPAs, service projects and leadership endeavors of our AGO sisters. They are committed to their studies yet make time to impact their college community in so many ways. We know they are on their way to becoming successful leaders and responsible members of society and we are proud to call all of them our sisters. Deciding on a scholarship recipient is not an easy task. We wish we could give all our applicants a monetary award. We hope that the Agonian Alumnae Association's financial support of our sisters is appreciated and as these sisters join the ranks of alumnae, they too will support these scholarships efforts.
